

3. THAT THE OBJECTS OF THE TRUST SHALL BE:-

- (i) To establish, promote, setup, run, maintain, assists, support financially and or aid to or help in the setting up and/or maintaining and/or schools and other educational institutions.
- (ii) To establish manage maintain and run different type of technical, non-technical educational institutions, reading room, common room, library, college, residential public school for the benefit of rural urban and tribal children.
- (iii) To create awareness on social, moral, physical development and other interests of the people under area of operation through various social and charitable activities of general public utility.
- (iv) To grant, pay or give scholarship, prize, rewards and other financial assistance to students with a view to help them pursuing their studies.
- (v) To establish promote setup run or aid to child welfare centre, hostels, charitable dispensaries.

- (vi) To open, fund, establish, promote, run playground, parks for public use sports and game and other social welfare works and activities.
- (vii) To establish manage maintain and run different type of primary, secondary and higher educational medical education, handicraft and fine art.
- (viii) Establishment, maintenance and support of Engineering college, polytechnic college, I.T.I., Motor vehicle Driving, Teacher's Training, B.Ed., M.Ed. College and Paramedical Institute.
- (ix) To implement tools of micro level is planning and the participatory rural appraisal to ensure meeting of the development activities under taken. Ensure educational training to be provided to core groups for the fulfilment of the objectives micro insurance, micro finance and SHG formation.
- (x) To participate in various forestry schemes to ensure preservation of environment. To make people aware, an observatory to be established for the tree plantation and use other source of energy as bio gas, solar etc.
- (xi) To give, provide/and or render help and assistance to the farmers in the field of agriculture about new method.
- (xii) To run manage dispensaries, hospitals, medical camps for providing medical relief.
- (xiii) To provide relief measures among the society during the natural calamities like food, fire, famine, earth quake, cyclone and drought.

4. BOARD OF TRUSTEES

- (i) The management and control of the trust and trust properties shall vest in the Board of trustee.

5. POWER OF THE BOARD OF TRUSTEE

- (i) The trustees may accept any donation or contribution in cash or in kind from any person, firm, company, corporation, association, institution, or trust for furtherance of the object of the trust. The trustee may also take over management of any other charitable or public institution on such terms as they think fit and may manage such institutions.
- (ii) The financial year of the trust shall end on 31st March every year.
- (iii) The board of trustee has power to amend the rule and regulation of the trust by majority vote.

- (iv) The trustee shall keep an account or accounts with any bank or banks to operate such account or accounts three trustees jointly Secretary, President and Treasurer.
- (v) The board of trustee shall met as often as necessary and their proceedings shall be recorded regularly in minute's book to be retained for the purpose in any resolution to be passed touching the administration of the trust, the opinion of the majority shall revive it shall he competent, however, tor the trustees to decide matter by circulation. In case of there being equality of votes the president of the meeting has a casting vote for the purpose of deciding the issue.
- (vi) The trustees may appoint lawyers, managers, engineers or others employees for the purpose of management and supervision of the trust estate or for the carrying out other work for upholding the interest of trust.
- (vii) The trustees may reimburse themselves and pay and discharge out of the trust fund the all expenses incurred by them in or about the execution of the trust or any of their duties under these presents including traveling, fooding and lodging expenses.
- (viii) The Trustees may frame rules and regulation as to the duties and responsibilities of each trustee to appoint subcommittee and the mode of conducting any other matter connected with the administration of the Trust and its management.
- (ix) The board of trustees may by an unanimous vote of all the trustees for the time being except the trustees proposed to be

- (a) An un-discharge insolvent, or
- (b) Convicted of an offence, or

(xi) A person shall cease to be trustee in any of the following events:-

- (a) if he dies or
- (b) if he becomes bankrupt, or
- (c) if he becomes insane or otherwise incapable to act,

or

- (d) if he resigns his office
- (e) by reason of sentence of court of law.

(xii) The trustees shall cause true and accurate accounts to be kept of all money received and spend all matters in respect thereof in course of management of trust properties or in relation to the carrying out of the object and purpose of the trust as well as of all assets, credits and effects of the trust properties.



- (xiii) The number of Trustee shall not be less than three and not more than nine.
- (xiv) The Trustee may amend rule and regulation of the trust by majority of vote.

6. POWER AND DUTIES OF THE PRESIDENT


- (i) To conduct and preside over the meeting of the board of trustee.
- (ii) He will have a casting vote which he will exercise only when there is tie in meeting.
- (iii) To maintain and cause to maintain proper and correct minute of all meeting of the board of trustee in the minute's book.
- (iv) To exercise all such power which the board of trustees may confer upon time to time.
- (v) He will operate account of trust jointly with Secretary and Treasurer.

7. POWER AND DUTIES OF THE SECRETARY

- (i) He will operate the account of trust jointly with president and treasurers.
- (ii) He will responsible for the proper keep of the account of the trust.
- (iii) He will submit annual progress report and audit statement of account of the trust before the board of trust meeting.
- (iv) Secretary shall be custodian of all books and registers and other records related to accounts and trust matters.
- (v) To prepare or cause to maintain the final account of income and expenditure together with balance sheet for the financial year

- (vi) To exercise all such power which the board of trustees may confer upon time to time.

8. POWER AND DUTIES OF THE TREASURER

- (i) To operate bank account jointly with secretary and President.
- (ii) Maintain complete accounts of all receipts, payments, assets and liabilities of the trust jointly with secretary.
- (iii) In general and alongwith the other trustee performs all acts and function concerning the finance of the trust.
- (iv) To exercise all such power which the board of trustees may confer upon time to time.

9. MEETING OF BOARD OF TRUSTEE

- (i) The meeting of the board of trustee will be held at least of 2/3 times in a year.
- (ii) Secretary may also convene extra ordinary meeting with the consent of the president as and when required.
- (iii) The quorum for the meeting of the board of trustees shall be one third of the total number of the trustees of the board.
- (iv) A resolution in writing circulated amongst all the trustees and signed by a majority of the trustees shall be valid and effectual.
- (v) A trustee who is unable to be present at a meeting of the trustee may send his view on the agenda in writing and such expression of opinion shall be taken to be his vote on the matter concerned.
